- 1. <u>Rates and Applicable Taxes</u>: Applicable taxes and duties should be clearly indicated in the quotations. Rates without taxes and duties will be presumed that the quoted price is inclusive of taxes and duties.
- 2. <u>Validity</u>: The rates quoted for supply should be for a period of two years from the date of first order and the firm should also undertake the repeat pasting of the vinyl at the same cost during the validity period.
