- 3. **ESCALATION CHARGES:** No escalation charges will be entertained during the currency of the contract, once the service provider is accepted and contract is awarded.
- 4. **VALIDITY:** The rates quoted should be valid for a period of 60 days from the date of opening the quotations.
- 5. <u>E.M.D:</u> The service provider should be accompanied with <u>EMD AMOUNT @2% of the actual rate quoted</u> drawn in favour of "Silk Mark Organisation of India" by a <u>Demand Draft</u> payable at Bangalore from a Nationalized / Reputed banks.
