In this regard SMOI is inviting sealed quotations from the reputed firms to undertake the work of layout planning, interior designing, fabrication, erection and setting up of "Resham Ghar.;" Accordingly, it has been decided by SMOI to float a Tender Enquiry in two-bid system, namely technical and financial bids.

Tenders (both technical & commercial) should be submitted in separate sealed cover, with clear superscription "Cover- "A" as "Technical Tenders" & "Cover- "B" as "Commercial Tenders", enclosed in an outer sealed cover with clear superscription on outer cover as "QUOTATION FOR THE SETTING UP OF RESHAM GHAR AT CCICI". Tender received after due date and time shall not be accepted. After detailed analysis of technical tenders, the only bidders who are found to be technically competent will be considered for commercial tender and the date and time of

opening the commercial tenders would be decided on the same day by the committee. If the date is other than the date of opening then the same will be communicated to such eligible bidders separately. The commercial tenders will be opened in the presence of only shortlisted bidders or their authorized representatives who may wish to remain present at the time of opening of commercial bids.

Quotations will be opened on the same day i.e.03.10.2017 at 04.00 P.M. in the office.
- 2) The quotation must be completed in all respects. Terms & conditions etc. should be specified clearly.
- 3) The rate quoted should be given with all the specification of the material used.
- 4) E.M.D.; The quotation should be accompanied with an EMD amount of Rs 5000/- (Rupees Five thousand only) be enclosed along with quotation through Bank Demand Draft to be drawn in favour of "**Silk Mark Organisation of India,**" payable at Bangalore. Quotations received without EMD will be summarily rejected.
- 5) RATES AND APPLICABLE TAXES: The parties should clearly quote the rates and applicable taxes in their quotation separately. Any other statutory levies such as excise duty, service taxes etc are to be quoted separately and clearly by the parties for evaluation purposes and to conclude rate contract. If taxes are not indicated separately then it is presumed that rate quoted is inclusive of taxes.

The rates should be typed/written clearly strictly both in figures & words without any cuttings/Erasing/overwriting.

- 6) ESCALATION CHARGES; No escalation charges will be entertained during the currency of the contract, once the quotation is accepted and contract is awarded.
- 7) VALIDITY: The rates quoted **should be valid for twelve months** from the date of opening the quotation.
- 8) REFUND OF EMD: The EMD amount of the unsuccessful bidders shall be returned after the successful quotationer is finalized. The EMD of the successful quotationer shall be discharged only after satisfactory completion of the contract and execution of work to the satisfaction and within the time schedule.
- 9) TDS: TDS will be deducted as per rule. PAN No. should be indicated.
- 10) PAYMENT: The bills may be submitted along with the work executed
